- 2. Pursuant to the aforesaid judgment, a National Task Force on Mental Health Concerns of Students has been constituted. The Task Force launched its official website on 8th August 2025, which serves as a central platform to gather diverse perspectives from key stakeholders, including students of Higher Education Institutions (HEIs), their parents, faculty members, mental health service providers, and institutional representatives. The University Grants Commission (UGC), vide D.O. No. 15-23/2025 (CPP-II)(C.163104) dated 4th September 2025, has also requested all stakeholders to participate in the online survey available at <a href="https://ntf.education.gov.in">https://ntf.education.gov.in</a> to share feedback and suggestions aimed at strengthening institutional mechanisms for students' mental health and well-being.
  - The survey seeks confidential and anonymous responses on a range of themes such as:

· Campus environment, inclusivity, and belongingness;

· Sources of distress and systemic discrimination;

· Existing grievance redressal and mental-health support systems; and

Suggestions for strengthening student well-being mechanisms.

All universities and HEIs are expected to act with utmost gravity and promptness in implementing Hon'ble Supreme Court's guidelines, which aim to safeguard the mental health, dignity, and overall well-being of students across higher educational campuses.
